COMMERCE COMMISSION DECREE 2010 (Decree No. 49 of 2010)

# Commerce (Control of Prices for Supply of Electricity and Ancillary Services) Order 2012

Pursuant to section 39 of the Commerce Commission Decree 2010 and upon the recommendation of the Fiji Commerce Commission, I hereby make this Order—

### Short title and commencement

1. This Order may be cited as the Commerce (Control of Prices for Supply of Electricity and Ancillary Services) Order 2012 and shall come into force on the date of its publication in the *Gazette*.

## Control of prices for the supply of electricity

2. For the purpose of section 39 of the Commerce Commission Decree 2010, the prices for the supply of electricity and services pertaining to the supply of electricity in all quantities, qualities and grades or classes are controlled.

## Expiration of Order

3. This Order shall expire on 24th May, 2015 unless the Order is varied, extended or earlier revoked.
