Re: **Expression of Interest No. EOI 04/2024 – Provision for Security Services - Whole of Government**

The Government Tender Board in its flying minute No. 14/2025 dated March 10, 2025, approved the abovementioned Open Supplier Panel List for a period of five (5) years to the below tabulated suppliers allowing for suppliers to be on boarded or removed according to compliance and performance.

The Open Supplier Panel enables Ministries to engage with various service providers as per their individual requirements. Government agencies will assess proposals based on cost-effectiveness, service quality, and compliance with minimum wage regulations ensuring fair labor practices in line with the Ministry of Employment's regulations.

For procurement of security services below the tender threshold, Ministries will conduct procurement through competitive quotations.

For procurement above tender threshold, procurement will be conducted through a selective tender from the Fiji Procurement Office.

**Ministries and agencies with complex requirements or specifications and where contract value is higher than \$500,000.00 may opt for an open tender. This is to be discussed with Fiji Procurement Office.**

While utilizing this Open Supplier Panel List, agencies must remain mindful of their budget and ensure value for money. Value for money is the most advantageous combination of cost, quality, and sustainability to meet requirements within the required timeframe.

The supplier panel arrangement is effective from **24<sup>th</sup> March, 2025** and will expire on **25<sup>th</sup> March, 2030**.

Ministries and Departments should engage approved suppliers on an "as and when required" basis and set up a contract between the Ministry and the chosen company. **A copy of the contract is required to be sent to FPO** for record keeping and monitoring. To ensure compliance throughout the contract period, Ministries should independently verify the validity of a security company's Master License. Additionally, Ministries are responsible for confirming that all security guards employed by the company possess valid identification issued by the Ministry of Defence & Veteran Affairs. This verification is separate from the annual verification conducted by the FPO.

Officers involved in procurement for their respective agencies are required to maintain detailed records and diligently monitor the performance of suppliers throughout the contract period. Any concerns or complaints regarding supplier performance must be formally documented and communicated to the Head of

Procurement at the Fiji Procurement Office. Alternatively, officers may contact the feedback team on 3221248 or submit online feedback via the FPO page.

The FPO team will conduct performance reviews annually allowing new suppliers that comply to enter and suppliers that are not able to perform to be removed.

Please ensure that the contents of this letter are brought to the immediate attention of all officers involved in procurement and the facilitation of payments related to the aforementioned contract.
