Re: LPG Price Review – Effective 1st April 2023

Fiji Gas Pte Limited wishes to advise all its government agencies that FCCC has completed its recent assessment of wholesale and retail prices for LPG Products for the domestic market.

VAT Exemption

As per the Revised 2021/2022 Budget, Cooking Gas has been declared as a zero-rated product, exempt from VAT of 9% effective from 1st April 2022. VAT exemption will apply on all Cylinder products, while 9% VAT will apply on sale of Bulk and Auto gas.

The revised prices are to be **effective from 1st April 2023**.

The prices set out in Schedule 1, 2, 3 and 4 herein shall be the maximum retail and wholesale prices. The maximum authorised Wholesale and Retail prices shall be as follows:
